Starting with 1998, for 12 years, the managing partner of CRĂZNIC AND ASSOCIATES – ATTORNEYS AT LAW was a prosecutor at the Prosecutor's Office attached to the High Court of Cassation and Justice of Romania. During this time, Mr. Flavius Crăznic held leading positions, acting as Chief Prosecutor.

Mr. Flavius Crăznic actively participated at training courses in the United States of America and in the European Union organized by the U.S. Department of Justice, FBI Academy, Trier European Law Academy, Siracusa Superior Institute of Criminal Sciences, Catania University, Bayreuth University, Pau University and Rey Juan Carlos University.

Since 2010, Mr. Flavius Crăznic has been a criminal defense lawyer in cases in front of the National Anticorruption Directorate (DNA), the Directorate for Investigating Organized Crime and Terrorism (DIICT) and the High Court of Cassation and Justice of Romania.

Determined, professional and intuitive, Luiza assists lawyers in clients meetings, provides administrative support and organizes the primary accounting activities of the law firm.



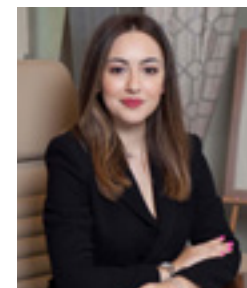

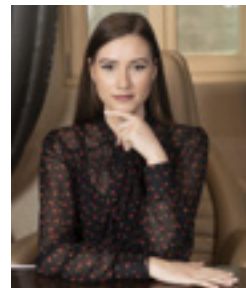
